

**AN ORDINANCE PROVIDING FOR THE POSTING OF  
BYLAWS RESOLUTIONS, AND ORDINANCES OF THE CITY  
OF GREENLAND, ARKANSAS, AND DETERMINING FIVE  
(5) OF THE MOST PUBLIC PLACES IN GREENLAND,  
ARKANSAS, FOR THE PURPOSE OF POSTING  
ORDINANCES, BYLAWS, RESOLUTIONS, AND NOTICES.**

WHEREAS, the City of Greenland is required by Arkansas Code Annotated Section 14-55-206 to either publish or post written or printed notice or any law or ordinance,

WHEREAS, there is no newspaper published in Greenland, Arkansas,

WHEREAS, the most effective way of notifying the citizens and residents of Greenland of bylaws, resolutions, and ordinances of a general or permanent nature is to post same in public places within the City of Greenland.

WHEREAS, The City Council of Greenland, Arkansas is required to designate five (5) of the most public places in Greenland, Arkansas, which shall be utilized for the aforesaid posting, and

WHEREAS, the City Council needs to give specific guidelines concerning the posting of bylaws, resolutions, notices, and ordinances

**NOW, IT IS HEREBY DETERMINED AND ENACTED BY THE CITY COUNCIL OF  
THE CITY OF GREENLAND, ARKANSAS,**

**SECTION 1:** That all laws, bylaws, resolutions, notices, or ordinances of the City of Greenland, Arkansas, hereinafter adopted or enacted shall be posted in the five (5) hereinafter designated public places for a period of not less than thirty (30) calendar days.

**SECTION 2:** Such posting, as aforesaid, shall occur within seventy-two (72) hours of adoption or enactment, shall be done in a manner which provides reasonable protection for the documents against the elements, the posting should ensure that the full text of the resolution, bylaw, notice or ordinance is visible to the public or that the full title and first page of the text is visible with written advice to the effect that a complete copy of the entire text of the bylaw, resolution, notice, or ordinance is available to the public at the office of the City Recorder/Treasurer in City Hall during regular office hours.

SECTION 3: That the official or employee of the City of Greenland who posts each such law, bylaw, resolution, notice or ordinance shall record the date of posting, the date of removal, and the locations where posted in a permanent Record to be maintained by the City Recorder/Treasurer.

SECTION 4: That the most public places in Greenland, Arkansas, for purposes of posting all bylaws, notices, resolutions and ordinances are hereby determined to be:

- 1) East side of bathroom in Greenland City Park-Taylor Park;
- 2) North side of Community Center near front door;
- 3) East wall of Greenland Public School Middle School Building by Administration Entrance;
- 4) North Wall of Dee Lee Gym by entrance; and,
- 5) South side of City Hall Building near Court entrance.
